



The Contribution Rebate Program

What is the Contribution Rebate Program?

Under the Contribution Rebate Program, contributors can receive a rebate from the City for contributions made to mayor and councillor candidates in an election. There are application rules and procedures that must be followed by the candidate and contributor in order for the City to pay a rebate.

Please note - the contribution limit for Vaughan Mayoral Candidates is \$1,200.

Application Rules

- only monetary contributions from individuals are eligible for a rebate.
- contributions of goods or services are not eligible for a rebate.
- corporations and trade unions cannot contribute to candidates running for mayor or councillor.
- any contributions that contravene the Municipal Elections Act, 1996 are not eligible for a rebate.
- a contributor, who gives to multiple candidates, cannot give a total of more than \$1,200.
- failure to do so may result in a fine up to \$25,000 or imprisonment.
- the candidate must close their campaign before their contributors can receive a rebate.
- if a candidate is involved in a compliance audit proceeding, their contributors will not receive a rebate until the process has been completed.

Application Procedure

The DeSantis campaign will:

- provide all contributors with a receipt, a personalized rebate form and file an audited financial statement.
- ensure that all rebate forms submitted prior to the deadline are properly registered with the Vaughan Elections Office.

Contributors should:

- complete the Rebate Application section of the form as soon as possible.
- mail the rebate form to Clerk of the City of Vaughan, 2141 Major Mackenzie Drive, Vaughan, ON, L6A 1T1 prior to **June 30, 2023**.
- keep a copy of the form for their records.
- if the information in the Contributor Receipt section on the form is incorrect, contact the DeSantis campaign.
